We hope you will enjoy and appreciate the new format of this newsletter. We have engaged the services of an alumni service to help us coordinate with the Chapter.

The information returns from the alumni have been most rewarding and we encourage you to send back additional news with your dues.

As previously reported by us, as well as the District Chief at the Convention, and by the Chapter in the Beta Magazine, the conditions at the House continue to be in excellent shape. The sprinkler projects are completed and we are continuing to work with the Chapter toward further upgrading of the Houses. In the energy area we have had extensive audits performed by consultants hired by MIT. The boys are contributing a substantial amount of work to these projects and the dollar pay-back for the ones the alumni are starting is very rapid.

Several of us attended an all day Alumni Inter-Fraternity Council Meeting at MIT in early April which was a joint program with the undergraduates. It was a very productive meeting and demonstrated the ongoing desire of the Institute to help the fraternities. MIT has prepared a model set of by-laws for fraternities which provides for one corporation with two sets of officers, one for the Alumni Association and one for the Chapter. The objective is to streamline the tax and legal interfaces as well as to limit liabilities. We are studying the model and may recommend a special meeting in the fall for adoption. We would welcome the help of any attorneys in our organization in addition to Yardley Chittick '22 who has offered to help.

The Annual Meeting will be held at Kresge at 5:00 P.M. on Alumni Day, Friday, June 5, 1981. We hope you can join us.

In any case, please forward your dues and personal news in the enclosed envelope, and try to add a capital donation to help with the sprinkler mortgages.

House Manager's Report

This past year the Beta House encountered many problems; however, with the help of the alumni and the efforts of the Brothers' "work force" we've been able to deal with the difficulties.

Over the summer a sprinkler system, purchased by the alumni, was installed in the Annex to meet the required safety codes. The glory of this new addition to the House, as well as the acquisition of a much needed new carpet for the living room (partially funded by the alumni) was marred by the discovery of the breakdown of our old industrial refrigerator when we returned from summer vacation. As the machine was determined to be beyond repair, we made do with three rented home 'fridges' for the first term and bought, again with help from alumni funds, a new industrial model at the beginning of the second term. During our January work week, we installed smoke alarms and fire extinguishers and repaired the emergency lights. Funds for these projects as well as for a new meat slicer to replace the broken one also came from the alumni.

We've painted much of the interior of both Houses, refinished most of the floors in the main House, modernized several of the most needy bathrooms, and attended to many of the plumbing problems that have plagued the House for years. We hope to be able to continue with the trend toward improvement of the House, and we are extremely grateful to the alumni without whom most of our projects could not have been possible.

Tribute To Clive W. Lacy, 1915

We are saddened to report the recent death of Clive W. Lacy, Class of 1915 and one of the founders of the Beta Upsilon Chapter at MIT.

Brother Lacy's contributions to the Chapter over a period of more than 65 years are legendary and include service as Chapter Treasurer, as well as President and a Director of Beta Upsilon Association for many years. In 1925, he managed the purchase and renovation (complete with barn) of the Chapter House at 241 Kent Street, Brookline, as well as the subsequent purchase and move in 1946 from Brookline to Bay State Road.

Brother Lacy was born in Dubuque, Iowa and after graduation spent most of his career with William Filene's Sons Co. in Boston. He served as a Lieutenant in the 90th Aero Squadron in France during World War I and was a Colonel in the Chemical Warfare Service in World War II for which he received the Legion of Merit. He was proud and pleased that his three sons, John W. Lacy '42, William R. Lacy '43, Thomas B. Lacy '48, and John's son Roger W. Lacy '79 all became members of Beta Upsilon. John has been Treasurer of Beta Upsilon Association for more years than almost anybody can remember and is responsible in large measure for the excellent financial condition of the Chapter and Alumni Association.

The annual Rush Picnic held each fall at Brother Clive Lacy's Newton estate has been a memorable Beta Upsilon tradition since 1940 with cookouts, games, camaraderie, and pledge bidding to be remembered by many MIT Betas.

Brother Lacy was always exhilarated and pleased with the enjoyment and friendships derived from his association with Beta Upsilon and Beta Theta Pi.

Another Founder

The tribute elsewhere in this letter to one of the Chapter founders, Clive W. Lacy '15 brings to mind that one of Mr. Lacy's classmates and a fellow founder of the Chapter was William R. McEwen '15 who died in 1957. Mr. McEwen was the father of Bill McEwen, Jr. '48 who has been the Secretary of Beta Upsilon for many years.
