Plans Underway to

Keep Careful Eye

on House Finances

As we all know, for a chapter to be strong it must be full of spirit and also financially sound. The first condition is easily satisfied at all times at the Beta Upsilon chapter and I am pleased to report that the second condition is also met.

The budget for fiscal year '82-'83, prepared by last year's Treasurer Chris M. Kurker '84, probably holds a few surprises for alumni who haven't thought much about house bills since their graduation. The total house budget comes to \$122,930. This is divided into three catagories. Chapter expenses total \$18,640. House expenses total \$53,400. Food program expenses total \$50,890. With twenty-five brothers and fourteen pledges living in the house, the current monthly housebill is \$341.

The mid-year accounting shows some good and bad news. The largest problem is that for the Fall of 1982, the house manager expenses exceeded the budgeted amount by \$4,800. Since we still have enough funds to cover utilities, the way to correct this problem is to carefully restrict non-essential house manager costs. Money spent on food alone exceeded budget by \$450 which comes to approximately 4%. Thanks to Rush Chairman Bill Maimon, '84, our highly successful rush was \$900 under budget. Other good news included low heating bills due to the mild winter and recent state ruling which now places fraternities exempt from the restaurant meal tax. For a grand total the chapter is currently \$2,300 over budget which is slightly under 4%.

Since totaling these figures I have spent time talking with other house officers on how to control the problems. We feel that the problems can be solved by careful watching of expenses to plan accurately and to cut any useless or wasteful expenses. This is sound advice for anytime.

Emergency lights, paid for by the alumni, were also installed in both houses. At a recent "Wish List" meeting between house and alumni officers, it was decided to seek advice on, and then to buy and install, a new heating system for the main house, to replace our 100-year-old system. It was also decided to repoint the back walls of both houses, which should cut down on both drafts and bees' nests.

Other areas which need to be addressed soon are the electrical wiring in both houses, and insulation in the rear of the main house. Also, plumbing problems often arise, although replumbing will have to wait for additional funding.

The brothers would like to thank the alumni for their continuing and generous support, which is so important to a strong chapter.


