Beta Brothers Meet Fraternal And Academic Challenges

I am happy to report that the Beta Upsilon Chapter of Beta Theta Pi is doing exceptionally well and is constantly striving to improve. This past year was very challenging, both academically and fraternally. Our chapter was given the honor and responsibility of colonizing the University of Rhode Island, performed a model initiation at the northeast workshop, and worked hard in hopes of receiving its second Sisson Award after being bestowed the honor last year. I believe we performed well in the face of all

The general status of the chapter is good. This year we were committed to creating stronger ties between ourselves and our alumni. Communication between actives and alumni became more frequent, alumni were at the house on a regular basis, our fraternal fifties were honored, the alumni party was a success, and our alumni corporation is pleased with our overall

As always, our chapter was active in varsity as well as intramural sports. Brothers from our chapter participated and distinguished themselves in the following varsity sports: soccer, baseball, basketball, wrestling, crew, sailing, lacrosse, indoor track, and rugby. Brothers from our chapter were the captains of basketball and lacrosse. We also participated in almost every intramural sport at MIT and excelled in basketball and softball. We finished second overall in B-league basketball and won the championship in A-league softball.

Even with all the participation in sports, our chapter had an exceptionally high grade point average. Our house cumulative average for the fall semester was a 4.5 out of 5.0, and an equally strong performance is expected for the spring semester.

The pledge programs this year were very challenging indeed. Brother Earl Watkins '90 did an excellent job of educating our pledges in Beta lore, songs, and Beta spirit. Brothers William Scruggs '92 and Mark Cooper '91 also did an outstanding job in motivating and instructing the founding fathers of the University of Rhode Island colony. As a result of these brothers' untiring devotion, the true meaning of Beta Theta Pi was instilled in all of our new initiates.

While this past rush was not as strong as those of the preceding few years, we nevertheless pledged an outstanding group of men. Seven men pledged this year, somewhat short of expectations. However, this was not detrimental to the house at all because our previous rushes were so strong. While initial goals were set, our philosophy during rush is to not reduce the activity to that of numbers. In the end, the ultimate goal is to pledge only those men who we feel have what it takes to become Betas.

Our social calendar was intense this year. We work very hard at MIT, but we also like to party and relax. We sponsored many parties and cocktail hours over the year and many socials with various sororities. All of our events were well attended and enjoyed. I am also happy to say that our neighbor relations did not suffer at all because of our social activities. All enjoyed themselves in a responsible manner.

As mentioned earlier, we were given the honor of colonizing the University of Rhode Island. As a result of this and the northeast workshop, we performed three initiation rituals this past semester. I believe these ceremonies were performed well and were consistent with those of the General Fraternity. I am very proud of the gentlemen who performed these ceremonies as well as those men who were initiated during the rituals.

Our community involvement was active as always. The brothers of this chapter each performed a minimum of 20 hours of community service at the Margaret Fuller House for underprivileged children in Cambridge. Various construction and general maintenance tasks were performed, and a haunted house was set up and manned by the brothers on Halloween. In appreciation for our work, the kids made us cards, and the operators of the house cooked dinner for us. Also, the InterFraternity Council at MIT was honored by the mayor's office for a community service project in which the brothers of the Beta Upsilon Chapter were very active. The community service project was performed last year, but the award was presented this year. This award was a framed copy of the newspaper article that documented the community service project. Prominent members in the photograph that accompanied this article were men wearing the letters Beta Theta Pi.

One area we could improve is that of campus involvement. Our reputation on campus is good because of our social activities, but we do not participate actively in student government and other similar groups. Although the brothers are not particularly interested in this area, we have no difficulties with the MIT administration. It is clear that student government offices are accessible to members of this chapter. Robert Ramstad '90 will be serving as a member of the InterFraternity Council's judicial committee review board for the coming school year. This board is responsible for hearing and ruling on all cases concerning any member house of the IFC, especially cases regarding rush or the IFC's party policy.
